

- The arrangements for attendance and voting at this year's Annual General Meeting are explained in the Chair's letter in Part I of the Notice of Annual General Meeting. Any changes to the Annual General Meeting arrangements will be communicated to shareholders before the Annual General Meeting through our website: https://www.mortgageadvicebureau.com/investor-relations/shareholder-services/agm-information.
- 2. A member may appoint a proxy or proxies (who need not be a member of the Company) to exercise all or any of their rights to attend, speak and vote at the meeting, if attendance is permitted.
- 3. You can appoint the Chair of the meeting or anyone else to be your proxy at the Annual General Meeting. You can also, if you wish, appoint more than one proxy provided that each proxy is appointed to exercise the rights attached to a different share or shares held by you.
 - To appoint the Chair as your sole proxy in respect of all of your shares fill in any voting instructions and sign and date the form of proxy - leave all other proxy appointment details blank.
 - To appoint a single proxy other than the Chair in respect of all of your shares, delete the words 'the Chair of the . meeting' and insert the name of your proxy in the space provided. Please initial the amendment.
 - To appoint more than one proxy, (an) additional form(s) may be obtained by contacting Equiniti on +44 (0) 371 384 2030 (lines are open 8.30 am to 5.30 pm Monday to Friday, excluding public holidays in England and Wales) or you may copy the form of proxy. You must complete a separate form of proxy for each proxy unless you are appointing your proxies electronically in which case please refer to notes 9 and 10 below. Please indicate, on the line underneath your proxy holder's name, the number of shares in relation to which you authorise them to act as your proxy. Please also indicate, by marking the box on the proxy form, if the proxy instruction is one of multiple instructions being given. All forms of proxy must be signed and should be returned to Equiniti.
- The proxy must attend the meeting in person to represent you. The completion of a form of proxy does not preclude Δ the member from attending or voting in person, if attendance is permitted.
- 5. Please indicate how you wish your proxy to vote on the resolutions by inserting 'X' in the appropriate space.
- 6. The 'Vote Withheld' option is provided to enable you to abstain on any particular resolution. However, it should be noted that a 'Vote Withheld' is not a vote in law and will not be counted in the calculation of the proportion of the votes 'For' and 'Against' a resolution.
- In the case of a corporation, the proxy must be under its common seal (if any) or the hand of its duly authorised 7. officer or attorney or other person duly authorised in that behalf. In the case of an individual, the proxy must be signed by the appointor or their attorney duly authorised in writing.
- In the case of joint holders, the signature of only one of the joint holders is required but, if more than one votes, the 8. vote of the first named on the Register of Members will be accepted to the exclusion of other joint holders.
- In order to be valid an appointment of proxy must be returned (together with any authority under which it is executed) in hard copy form by post to the Company's Registrars at Equiniti, Freepost RTHJ-CLLL-KBKU, Aspect House, Spencer Road, Lancing, West Sussex BN99 8LU or by hand to Equiniti at Aspect House. Spencer Road, Lancing, West Sussex, BN99 6DA, not later than 1.00 pm on Monday, 20 May 2024 (or, in the case of an adjourned meeting, by no later than 48 hours (excluding any part of a day that is not a working day) prior to the meeting). Any alteration made to the form of proxy must be initialled. As an alternative to completing the hard-copy proxy form, you can appoint a proxy electronically by visiting www.shareview.co.uk. You will need to create an online portfolio using your Shareholder Reference Number (this is the number printed on your proxy form). Once logged in simply click "View" on the "My Investments" page, click the link to vote and follow the on-screen instructions. To be valid, your proxy appointment(s) and instructions should reach Equiniti not later than 1.00 pm on Monday, 20 May 2024 (or, in the case of an adjourned meeting, by no later than 48 hours (excluding any part of a day that is not a working day) prior to the meetina).
- 10. CREST members who wish to appoint a proxy or proxies through the CREST electronic proxy appointment service. may do so by using the procedures described in the CREST manual. A CREST message appointing a proxy (a "CREST proxy instruction") regardless of whether it constitutes the appointment of a proxy or an amendment to the instruction previously given to a previously appointed proxy must, in order to be valid, be transmitted so as to be received by the issuer's agent by the latest time for receipt of proxy appointments.
- 11. Only persons entered on the Register of Members of the Company at 6.30 pm on Monday, 20 May 2024 (or, if the meeting is adjourned, at 6.30 pm on the date which is two days prior to the adjourned meeting, excluding any part of a day that is not a working day) shall be entitled to attend and vote at the meeting or adjourned meeting. Changes to entries on the Register of Members after this time shall be disregarded in determining the rights of persons to attend or vote (and the number of votes they may cast) at the meeting or adjourned meeting.
